

Address of Outgoing President Dr. Kennert Torlegård

Distinguished Participants in the XVIIth Congress of ISPRS, Ladies and Gentlemen.

Directions for their work is formulated in the Resolutions which have been adopted by the General

Assembly and then endorsed by the Congress. More general guidelines are given in the Statutes and the Bylaws. In addition I would like to add a few remarks and wishes for the future, if I may.

- Officers of the Society should always have among themselves an open attitude in discussions and deliberations
- Council and Commissions should try to find a consensus in opinion before you make a decision
- But do not hesitate to make a decision without the consent of everybody, if it is necessary to make progress
- Communication with and dissemination of information to the Members is of the utmost importance, both from and to Council and especially between Technical Commissions and Working Groups on the one hand and Ordinary, Regional and, Sustaining Members on the other.
- Submit papers, news, reports, reviews etc. to the Editors of the official Journal, and encourage institutions, corporations and individuals to subscribe
- Develop more contacts with other international organizations related to photogrammetry and remote sensing, for example in fields of surveys and mapping, space sciences, image and vision sciences, earth sciences, GIS, environment and natural resources.
- Remember that the Society subscribes to nondiscrimination on a basis of politics, nationality, religion, or sex, and remember that the advancement of our sciences is ultimately done to improve the quality of life of man wherever he lives, and to improve the possibilities for more people to live in peace on Earth.

In the past Congress period we have seen many changes on the political map of the World. This has also had effect on our Society. Some of the Ordinary Members have changed names and organizational form. When Germany was re-unified the Society lost one Member. Due to the political changes in central and eastern Europe, the Society has new Members at this Congress representing Estonia, Latvia, Lithuania, Ukraine, Belarus, Slovenia, and Albania. Other new Members are Azerbaijan, Bophuthatswana, and Saudi Arabia. Further changes in the Membership will most likely take place in the coming four years.

The Society has now an important role to play. The new members can benefit from the scientific and technical development which is coordinated and presented through the Society at symposia, colloquia, congresses and other meetings. The Society also can offer a network to colleagues in other countries, contacts can be established and exchanged of experience and support can follow. It is all within the scope of the Society: to develop the international cooperation for the advancement of photogrammetry and remote sensing and their applications. But how much this is worth and

to what extent it will take place that depends on you and me as individuals. We have to convince decision-makers at various levels, and above all we have to make use of the resources we have at hand, whether in universities and colleges, in private enterprises offering hardware, software and services, in governmental agencies and ministries. We can work in international projects, we can initiate projects, some of us can decide about funding and policy for international cooperation. It depends on us, you and me, what will be done! Photogrammetry and remote sensing cover disciplines that are applied in research laboratories, in industry, in municipal planning, in national mapping, environmental and natural resources monitoring over larger regions. We all can use our position to contribute to the process of making the Earth a better place to live on.

As President I have had many opportunities to meet photogrammetrists and remote sensing experts and to listen and learn and to discuss the scientific, technical and managerial matters of our disciplines and their roles and relationships to other parts of the surveying and engineering sciences. I am very grateful for this experience, and for all the good relations and friendships that have developed during these four years.

Address of Incoming President Dr. Shunji Murai

Mr. President, Distinguished Delegates, Ladies and Gentlemen!

It is my great honor to have been elected as the new President of ISPRS that has 94 Ordinary members and a history of more than 80 years.

First of all, I would like to thank my teachers. Dr. Frederick Doyle, the past president for 1976-1980, taught me why Japanese scientists had to contribute to the Society. Fred ordered me not to escape from international cooperation simply because of the language handicap.

I was lucky to have been able to work together with Prof. Gottfried Konecny on the Council for the past eight years. Gottfried has been always a God-father to me and I tried to be a good son. Gottfried taught me the difference between an elephant and a crocodile. # Address of Outgoing Congress Director Lawrence W. Fritz

Distinguished delegates and participants in the 17th ISPRS Congress, Ladies and Gentlemen,




