## 1. Opening Remarks

CH opened the meeting at 9:45 CET on Feb. 21.

# 2. Approval of the Agenda

The agenda was approved.

### 3. Approval of CM Minutes from 21 January 2022

## 5. Congress 2022

## 5.1 Actions before Congress

The actions have all been carried out to date.

## 5.2 General Assembly

The agenda of the General Assembly (GA) was discussed in detail; LH was asked to amend it as per Cnl decisions.

TC V proposal for resolution of TC V which mentioned important topics for the 2022 – 2026 Commission V was discussed. It was decided to send the proposal to the proposed new TCP V.

In 2020, ISPRS selected two papers for the Young Author Awards per TC, in 2021, one per TC. In 2022, up to 2 very good papers per TC shall be selected by the TCPs. NP has informed TCPs.

# 5.3.2 Status of Helava and Dangermond Award

Deadline for the U.V. Helava and Jack Dangermond Award 2022 is 20 March in order to inform winners on 1 April.

Also, the status of the Forum and the Technology tracks was presented and discussed.

#### 5.5.2 Poster Sessions

The possibility to launch a call for interesting poster presentations (without publications) on topics related to ISPRS was discussed. In order not to overlap with offers to companies for the technical track, this launch – if realised – would probably be limited to young authors of research establishments. A decision on was postponed to the next meeting.
